#### 1. Interlibrary Loan Policy:

- a. Both the parties agrees to follow Interlibrary Loan (ILL) as a service that allows students, faculty, and staff to borrow books, articles, and other materials from library of other party (college).
- b. Requests should be made through the librarian of the college.

## 2. Eligibility for Interlibrary Loan service:

- Students, faculty, and staff of the above parties are all eligible for interlibrary loan privileges.
- b. Borrowing privileges from the Library will be suspended, however, if a patron fails to return borrowed materials, or fails to pay any invoices in a timely manner.

### 3. Interlibrary Loan charges:

a. Interlibrary Loan is a free service

## 4. Late returns of interlibrary loans:

a. It is agreed upon the late return of the borrowed items shall be charged with Rs.1/per day from the date of overdue and will be blocked from requesting interlibrary

loans and checking out books until the overdue interlibrary loans are returned and fines paid.

## 5. Interlibrary loan limitations and restrictions:

- a. The Library will process up to 10 active requests per student. When requesting more than 10 items, a patron will be asked to indicate priority.
- b. Interlibrary loan items cannot be placed on Course Reserve.

#### 6. Duration of Loans

- a. The loan period, renewals, and conditions of use are determined by the lending library.
- b. If a renewal is necessary, a renewal request should be made a 2 days before the date the item is due. Late items cannot be renewed.

## 1. AREAS OF COLLABORATION

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

- Academic and Research collaboration in the areas of mutual interest.
- Exchange of academic information, scholarly information, materials and publications.
- Exchange of students and faculty.

Sponsorship of cooperative seminars, workshops and other academic meetings.

## 2. Student Exchange

Pursuant to the agreement for academic exchange, PARTNER INSTITUTION and Astha Mahavidyalaya will exchange students.

## 3. Faculty Exchange / Mobility:

On invitation by the host institution, teaching staff may go for a teaching stint at the partner institution with due approvals on either side. Financial commitments will depend upon availability of support from funding agencies.

## 4. Research Collaboration

Faculty from both Institutions will collaborate in the supervision of exchange students and in joint research in disciplines of mutual interest.

# 5. Commencement, Renewal, Termination and Amendment

- a) This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for a period of FIVE years from the date of the last signature. This MOU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MOU at the end of the five years period it must notify the other institution no less than six months prior to the expiry of the MOU.
- b) This MOU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two institutions. For all issues arising out of this

c) Memorandum of Understanding or in its implementation the concerned parties to this MoU will resolve the same amicably by mutual consent of both the parties.

d) Both Parties understand that all final arrangements will have to be negotiated and will depend on the availability of funds. During implementation of the present MoU both Parties shall comply with legal regulations being in force in both countries.

e) This MoU was made in two equivalent copies in English, with one copy for each Party. The signing parties signed the agreement themselves digitally in person.
